

## Noble 8 Revolution Do's and Don'ts "Snapshot"

### DO's:

1. ALWAYS use professional images and colors on all advertising.
2. Have a Noble 8 Facebook Group Page with the disclaimer statement, **Independent Business Leader of Noble 8 Revolution**", placed on the MAIN "Cover" picture at the top. In the "About" statement of the group, must also say "This is NOT an official corporate group; it is brought to you by an Independent Business Leader of Noble 8 Revolution".
3. Advertise on Social Media sites; Facebook, Pinterest, Twitter, etc. with the same disclaimer statement.
4. Use the company videos as needed as long as you make NO changes, except to insert the disclaimer statement along with your contact information and enrollment link.
5. Enroll customers in any legal manner and adhere to our Policies and Procedures.
6. Run your own conference calls and trainings using approved company materials.

### DON'Ts:

1. Use the Noble 8 Revolution name or Logo in an email address or on business cards, flyers, postcards, car signs, apparel, etc.
2. Make any "income statements" or claims.
3. Use "tacky" or unprofessional artwork or verbiage in advertising.
4. Purchase domain names using any form of the Noble 8 name as there is no way to have the disclaimer in the domain name.
5. Use any verbiage indicating that you are part of the corporate team or that you are representing Noble 8 as a legal representative.
6. Enter into any contracts, phone service, leases, etc. using the Noble 8 name.
7. Run examples of potential income on Excel spreadsheets, other documents or tables.

8. Change any company audios or videos in any way other than to insert the disclaimer statement along with your contact information and enrollment link.
9. Make your own videos representing Noble 8.
10. Make your own Power Point presentations of any kind.
11. Change the name Noble 8 Revolution to N8, or any similar variation, to circumvent the disclaimer statement. Always use the full name in advertising.
12. Change "Independent Business Leader" to "IBL" as the public would have no idea what that means. (i.e., "IBL of N8") Must use "Independent Business Leader of Noble 8 Revolution".
13. "SPAM" others with random emails that are NOT friends and family or "Opt-in" Leads from our IBL Support site. (Any emails that are returned as SPAM sent by you will cause a Compliance Questionnaire to be generated. If the email harms the company in any way, other measures may be taken.
14. Use your Noble8Now.com/Username enrollment link on Facebook. Always "mask" your enrollment link. (i.e., TinyURL.com, Google, [Bitly](#))
15. Cross Recruit or Poach; try to get an existing IBL (their spouse, child, etc.) to take a position in your line, attempt to sponsor an existing IBL into another opportunity or otherwise disrupt the Noble 8 business.
16. Disparage another IBL, the management or the company.
17. Attempt to keep your team from attending company calls, events and trainings.
